



Application Guide Jean Langevin Award

1. Jean Langevin Award

In order to facilitate and encourage the implementation of the community policing approach, the Intersection Network, created in 2017, the Jean Langevin Award. This award aims to recognize people whose overall achievements constitute a contribution to the development and promoting the community policing approach.

The award, presented annually, rewards a person for the excellence of all their accomplishments. It thus helps publicize the importance of the work executed in understanding, applying and developing the community policing model and promote the application of the community approach.

2. Eligibility

Any person working in a police organization or employee of a corporation or institution member of the Intersection Network and whose activities are related to the community police approach is eligible.

In addition, the person nominated must not be or have been the subject of a complaint or a indictment under the Code of ethics of police officers, a disciplinary regulation or the Criminal Code.

In addition, the candidacy presented must not have been a winner of the Jean Langevin Prize in the last 10 years. If the application has already won the prize in a previous edition, you must ensure that the actions and achievements presented in it are striking and innovative.

3. Application

The application can be presented by a person, a group or a public or private association. It must have the support of the chief of police or the organization where the person works and this organization must be an active member of the Intersection Network.

The application must highlight the different facets of the community approach as well as the sustainability of the actions taken. The innovative nature of the actions and achievements presented as well as their contribution in terms of promoting the application of the community approach should be underlined. It is also important that the relevance of the actions taken can be demonstrated, as well as their impact on the outreach and the very foundation of community police.

The application file must specifically state the partnerships developed in order to carry out certain actions. In addition, the file must state the achievements that have resulted and their sustainability.

If necessary, some additional documents could be attached. The documents must only be of documentary nature (no audio, visual documents, etc.) and must not exceed 10 pages.

Once the file is completed, it must be sent with the completed nomination form by email to the following address: renseignement@policewendake.com

Applications can be sent throughout the year. However, to be eligible for the fall edition, these must be received no later than June 21 of each year, the stamp of the email reception as proof.

4. Evaluation criteria

The members of the jury will evaluate and grade all applications according to the following elements:

- ❖ Application of the fundamentals of the community policing approach (partnership, community mobilization, problem-solving approach and strengthening of preventive measures¹);
- ❖ Development of the model (innovative nature of the approach in itself, how all of the candidate's achievements promote the appropriation and integration by the police service and by its partners of the components of the community policing approach, transferability of the model other police services and their partners, practical results related to the four fundamentals);
- ❖ Promotion of the model (visibility, influence, other means of promoting the model);
- Contribution for the progression of the model (implementation results, sustainability of the project).

This evaluation will focus on the detailed elements of the nomination form at the end of this guide. In addition, the quality of the writing will also be taken into account when assessing the files.

6. Award

The winner will receive a distinction testifying to their exceptional work in community policing. The award ceremony will be held at the annual Intersection / MSP Seminar.
