



# Application Guide Jean Langevin Award

### 1. The Jean Langevin award

The Intersection Network, in order to facilitate and encourage the implementation of the community policing approach, created in 2017 the Jean Langevin Award which aims to recognize individuals whose overall achievements constitute a contribution to the development and promotion of the community policing approach in Quebec.

This award, given annually, recognizes an individual for the excellence of his or her entire work. It contributes to publicizing the importance of the work accomplished in the understanding, application and development of the community policing model throughout Quebec and to promoting the application of the community approach.

### 2. Eligibility

Any person working in a police service or employee of one of the member organizations of the Intersection Network located in Quebec and whose activities are related to the community policing approach is eligible.

In addition, the nominee must not be or have been the subject of a complaint or charge under the Code of Ethics of Quebec Police Officers, a disciplinary regulation or the Criminal Code.

In addition, the nominee must not have won the Jean Langevin Award in the past 10 years. If the nominee has already won the award in a previous edition, it is important to ensure that the actions and accomplishments presented in this one are outstanding and innovative.

### 3. Application

The nomination may be made by an individual, group or association, public or private. It must be supported by the director of the police service or organization where the candidate works and the organization must be a member in good standing of the Intersection Network.

The application must highlight the various facets of the community approach and the sustainability of the actions taken. The innovative nature of the actions and achievements presented as well as their contribution in terms of promoting the application of the community approach must be emphasized. It is also important that the relevance of the actions can be demonstrated, as well as their impact on the influence and the very foundation of community policing.

The application file must concretely state the partnerships developed in order to carry out certain actions. In addition, the file must show the achievements that resulted and their sustainability.

If necessary, some additional documents could be attached. The documents must be of a documentary nature only (no audio or visual documents, etc.) and must not exceed 10 pages.

Nominations may be submitted throughout the year. However, to be eligible for the award at the Intersection 2022 Fall Seminar, nominations must be received by **midnight on June 30, 2023**, as evidenced by the e-mail receipt stamp.

### 4. Evaluation criteria

Ownership and integration by the police department and partners of the community-based approach must be felt throughout the applicant's accomplishments.

The evaluation will focus on the detailed elements of the nomination form at the end of this guide. In addition, the quality of the writing will also be taken into consideration when evaluating the applications.
